How, when, and what to apply for

Urban heat island reduction is a key initiative by Los Angeles County to help cool neighborhoods. Schools are among the hottest areas due to limited tree cover and extensive asphalt surfaces, which provide little relief from high temperatures. This increases the risk of heat-related illnesses and injuries for students and staff. Fortunately, grant funding is available to help schools modernize their campuses and improve resilience to extreme heat.
