PPC MEETING

I. ROLL CALL

Roll call was taken at 12:09 PM and a quorum was present.

II. COLLOQUIA PRESENTATION

"'Gay Boy Talk' meets 'Girl Talk': The Road to Risk is Paved with Good Intentions"

Dr. Rosemary Veniegas of the Center for HIV Identification, Prevention and Treatment

Services (CHIPTS) provided some background and introduced Dr. Matt Mutchler from

California State University, Dominguez Hills who provided the power point presentation.

Sexual health communication between young adults is one way sexual norms are established.

Most young adults spend far more time talking with their friends than communicating with

health educators or parents. But little research has explored how young gay men's

conversations with their peers might affect their sexual risk behaviors. The study used mixed

methods to explore how young gay men talk with their best male and female friends about sex.

The study used purposeful venue-based sampling to recruit an ethnically-diverse sample of 24

pairs of best friends, 18-21 year old, living in Los Angeles County. The study disclosed these

young gay men and their peers engage each other in supportive talk about safer sex practices.

However, in spite of these good intentions, their communication was also characterized by a

number of problematic attitudes and misconceptions that could undermine rather than reinforce

safer sex behaviors. Discussed were the implications for health promotion programs working with these young adults to better support safer sex behaviors.

V. PUBLIC COMMENT

- Andy Handler, LAGLC, announced a job opening for a Health Education Specialist in the Prevention on Wheels (POW) Mobile Testing Unit.
- Jeffrey King, Community Activist, announced at the end of calendar year 2009, he had the opportunity to participate in a budget briefing with Karen Bass (Speaker of the Assembly). Mr. King read a statement regarding HIV prevention and care and requested for the PPC (during the February, 2010 Annual Planning Meeting) to consider how to connect, educate and mobilize our Los Angeles County community to take focused, relentless and fearless action to restore HIV prevention and care services in Los Angeles County and the State of California. Mr. King suggested the PPC could consider thinking outside the box.
- Scott Campbell provided copies of two documents (an article from the International Journal of STD & AIDS Volume 21 January 2010) and (letter dated November 3, 2009 to All Commercial Sex Venue Owners signed by Jonathan E. Freedman). Mr. Campbell shared the rate of HIV in the study is four times less the current rate and based on the settlement with Los Angeles County, the CSV owners are required to pay for testing when the rate of HIV is 2% in the CSV's, which is far below the county rate.
- Jill Rotenberg announced the SPA 4/Service Planning Network (SPN) continues to meet on the 3rd Thursday of every month. The next SPA 4/SPN Meeting is January 21, 2010 at 12:00 Noon at Planned Parenthood with a presentation by JWCH on the Bath House Testing Initiative. Ms. Rotenberg left business cards on the back table for individuals interested in attending the meeting, contact Ms. Rotenberg.
- Charlie Romero, Bienestar, announced Bienestar is hosting it Birthday Bash targeting youth on January 28, 2010 at the Bienestar Hollywood location (4955 W. Sunset Blvd.).
 Additional information at My Space/Hollywood Bienestar. This is a free event and HIV testing will be provided.

VI. COMMUNITY CO-CHAIRS REPORT

- Terry Smith shared he was unable to attend the November 5th PPC meeting because he was attending the California Design Summit Meeting on that day and thanked the PPC for reelecting him as PPC Community Co-Chair.
- Terry Smith reminded the PPC members of the PPC Annual Planning Meeting scheduled on February 5th at St. Anne's Maternity Home to include discussion on the structure of the PPC and PPC processes.
- Terry Smith acknowledged John Mesta for his assistance in coordinating efforts for the PPC to develop a response to the White House on the National HIV AIDS Strategy (NHAS) and submitting the PPC response to NHAS to the White House.

VII. GOVERNMENTAL CO-CHAIRS REPORT

- Sophia Rumanes reported OAPP is in the process of obtaining signatures to fully execute contracts for all prevention programs.
- Ms. Rumanes shared the Centers for Disease Control and Prevention (CDC) has scheduled a three (3) day site visit to Los Angeles at the end of this month. Three representatives from the CDC (two Project Officers and one project supervisor) are scheduled to review the Cooperative Agreement and the Expanded Testing in the Jails Initiative and Routine Testing. The representatives from the CDC are interested in site visits with community partners.
- Sophia Rumanes reported OAPP has released the Request for Proposals (RFP) for the African American Faith Based Initiative. The details of the RFP are on the OAPP web site.

Lastly, Ms. Rumanes announced the Office of AIDS Programs and Policy (OAPP) is
collaborating on a grant awarded to Childrens Hospital Los Angeles (as the Adolescent
Medical Trials Network site) through NIH, CDC and Adolescent Trials Network. Ms.
Rumanes asked Miguel Martinez to provide further information on the terms regarding the
grant.

XI. BUDGET PLANNING PROCESS

Dr. Michael Green, OAPP Planning and Research, provided an overview of the budget planning process used by the Office of AIDS Programs and Policy (OAPP) last summer when the effects of the budget reductions to HIV and AIDS related services were released. Dr. Green shared the PPC had prioritized services (without regard to funding streams) and OAPP developed a set of recommendations which were shared with the PPC (Executive Subcommittee) and the Commission on HIV. During the overview and subsequent discussion, questions were answered. Sophia Rumanes shared some figures. Additionally, it was shared the first draft of the California Governor's budget will be released on January 8th. There was a

discussion regarding creating an ad hoc committee to discuss proposed budget cuts and how prevention is presented to the world.

Scott Campbell placed a motion on the floor to establish a Contingency Planning Ad Hoc Work Group and Jill Rotenberg seconded the motion.

XII. STANDING REPORTS

- City of Los Angeles
 - Ricki Rosales shared the City of Los Angeles is experiencing budget problems and the City of Los Angeles AIDS Coordinators received notice of approved funding for another year. The City of Los Angeles AIDS Coordinator's Office is working on a new Request for Proposals (RFP) for prevention. The City of Los Angeles and the Los Angeles City Council has completed the RFP process for clinic testing. Two sites have been selected (one St. John's Well Child Family Clinic and another clinic in south Los Angeles). The ban has been lifted on the Syringe Exchange Program and the City of Los Angeles AIDS Coordinator's Office has partnered with the National AIDS Housing Coalition and CHIPTS on a HIV Housing Summit on March 1, 2010.
- Alcohol and Drug Programs Administration (ADPA)
 Tim Young shared two meetings are occurring with ADPA and the community and invited everyone to attend. On January 21, 2010 from 10:00 AM to 12:00 PM at 11515 Colima Road in Whittier, ADPA is hosting its Prevention Round Table meeting with ADPA providers in the Gold Star Conference Room. On January 22, 2010 the ADPA Quarterly Provider Briefing Meeting is scheduled from 10:00 AM to 12:00 PM at the Lynwood Correctional Facility located at 11703 S. Alameda Street, Lynwood.
- Sexually Transmitted Diseases Program (STDP)
 John Copeland shared the Sexually Transmitted Diseases Program is experiencing budget problems. In December, 2009, STDP lost ten staff members due to budget cuts and is expected to lose another ten to twelve staff members. Mr. Copeland requested for individuals and other programs to advocate for STDP funding and eliminate working in silos
- HIV Epidemiology Program (HEP)
 Juli-Ann Carlos reported the new HIV Surveillance system is installed and provided an
 update: as of the end of 2009, there were 44,450 living HIV/AIDS cases in Los Angeles
 County with 19,807 HIV cases. Ms. Carlos reminded the group the HIV Epidemiology
 Reports are generated semi-annually.
- California Design Summit
 Ricki Rosales reported the California Design Summit held its last meeting on December 4th
 and December 5th and has completed developing the framework for the Community
 Planning Group. The CHPG no longer exists and a new community planning group has
 been formed. Information regarding the Community Planning Group can be found on the

State Office of AIDS web site. It was suggested for Ricki Rosales to continue to report California Planning Group (CHP) activities to the PPC.

Additionally, Mr. Rosales shared the California AIDS Clearing House is being managed by the State Office of AIDS and individuals/agencies requesting materials should contact CACTRANSITIONINFO@cdph.ca.gov. Sophia Rumanes shared OAPP has copies of the California AIDS Clearinghouse catalog and individuals/agencies interested in obtaining copies of the catalog should contact their Program Manager.

- Urban Coalition of HIV AIDS Prevention Services (UCHAPS)
 Kathy Watt shared the next UCHAPS meeting is February 28th March 1st in Houston
 Texas. UCHAPS will be creating a new Strategic Plan. The FY 2010 Omnibus Bill passed
 and Program Collaboration Service Integration (PCSI) telephone calls occur weekly. The
 PCSI White Paper is on the CDC website. UCHAPS is developing a Best Practices
 document on Syringe Exchange/Syringe Access Program. Kathy Watt announced Marlene
 McNeese-Ward, Houston, Texas, is the new Governmental Co-Chair for UCHAPS.
- Incarcerated Task Force
 Ron Osorio reported the Incarcerated Task Force did not meet in December 2009.
