I. COLLOQUIA PRESENTATION

"Community Viral Load"

Dr. Rosemary Veniegas of the Center for HIV Identification, Prevention and Treatment Services (CHIPTS) provided some background and introduced Dr. Moupali Das-Douglas, from the University of California at San Francisco Department of Medicine who provided a power point presentation.

Dr. Das-Douglas' power point presentation explored the concept that at the individual level, higher HIV viral load predicts sexual transmission risk. The San Francisco's community viral load (CVL) as a population level marker of HIV transmission risk was evaluated. The hypothesis that the decrease in CVL in San Francisco from 2004-2008, corresponded with increased rates of HIV testing, antiretroviral therapy (ART) coverage and effectiveness, and population-level virologic suppression could be associated with a reduction in new HIV infections. The San Francisco HIV/AIDS surveillance system to examine trends in CVL was used as the mean to examine trends in the viral load. The mean CVL was calculated as the mean of the most recent viral load of all reported HIV-positive individuals in a particular community. The total CVL was defined as the sum of the most recent viral loads of all HIV-positive individuals in a particular community. Reductions in CVL are associated with the decreased HIV infections. Results suggest that wide-scale ART could reduce HIV transmission at the population level. Other health jurisdictions should consider adding CVL to routine HIV surveillance to track the epidemic, allocate resources, and to evaluate the effectiveness of HIV prevention and treatment efforts.

There was a question and answer period following the presentation.

VI. LATINO TASK FORCE REPORT

Review and discussion on Latino Task Force Recommendations

The Latino Task Force Recommendations were an attachment to the October 7, 2010 PPC meeting agenda and additional hard copies of the document were available on the back table. Victor Martinez and Sergio Aviña, Latino Task Force Chairs, provided a power point presentation on the development of the Latino Task Force Recommendations document and highlighted the eight recommendations being submitted by the Latino Task Force. The motion on the October 7, 2010 PPC meeting agenda to approve, adopt and forward the Latino task Force Recommendations to the Office of AIDS Programs and Policy was seconded by Trevor Daniels. The floor was opened for discussion. There was a lengthy discussion. Kathy Watt offered an amendment to the motion to "approve, adopt and forward the Latino Task Force framework document to the Office of AIDS Programs and Policy". The Latino Task Force Chairs did not accept the amendment. It was stated that the Latino Task Force recommendations appear to be broad and vague and the question was posed, "how do these recommendations differ from other recommendations addressing populations (i.e. Transgender, MSM, Substance Abuse, etc.?" Victor Martinez suggested returning the recommendations to the Latino Task Force for clarification, additional information and to develop an implementation. Another amendment to the motion was placed on the floor to "approve, adopt and forward the Latino Task Force prevention strategy to the Office of AIDS Programs and Policy. The Latino Task Force chairs accepted this motion. However, no vote was taken. VIII. COMMUNITY CO-CHAIRS REPORT

- National HIV/AIDS Strategy (NHAS) Update
 Terry Smith reported the November 4th PPC meeting will be (mostly) dedicated to talking about NHAS. Mario Pérez has agreed to provide an overview of NHAS to the PPC. Mr. Smith encouraged everyone to go online and review NHAS. Additionally, at the November 4th PPC meeting, the PPC will determine the next steps and gather public input about NHAS. In the Meantime men's Group, Inc. has requested for the PPC to conduct a community-wide assessment of African American MSM that work in HIV and a Think Tank for providers that work directly with African American MSM to offer input on how resources that come into Los Angeles can be better utilized to elevate the already existing framework created by the PPC (through the Prevention Plan). This idea and other ideas will be looked at at the November 4th PPC meeting.
- PPC/Commission Integration Task Force Update
 Terry Smith shared the PPC and Commission on HIV (COH) have been meeting and
 working on an Integration Task Force for about one year. A couple of meetings ago, it was
 agreed the integration task Force will work on prevention and linkage to care through
 Treatment Linkage to Care Plus (TLC+). The PPC will be engaged in a systems mapping
 process (courtesy of the COH).

 Terry Smith reported Josh Riley, Ricki Rosales and Kathy Watt have been nominated and has accepted the nomination for PPC Community co-Chair. IX. GOVERNMENTAL CO-CHAIRS REPORT

Michael Green reported as a result of CDC funding announcements, OAPP has received funding for three new grants totaling about 2.8 million dollars for HIV prevention. All of the funding for the grants started on September 30th.

- 1. A supplemental award to the existing cooperative agreement for under \$400,000.00 which would take the total for the cooperative agreement for this year up to about 12.9 million dollars.
- 2. Phase 2 of the Expanded Testing Initiative (funding announcement 10138), OAPP was funded for Phase 1 of the Expanded Testing initiative which ended on September 29th. Phase 2 started on September 30th and OAPP has been funded for the next three years for a little over 1.3 million dollars per year.

3. The Comprehensive HIV Prevention Planning and Implementation award is effective September 30th for under 1.1 million dollars for the first year and there is a possibility for some of the funded jurisdictions to be funded for a second year and possibly a third year depending on the kind of prevention programs that are implemented using these particular funds.

Lastly, Dr. Green reported OAPP is awaiting a response from the CDC to a funding opportunity related to Hepatitis C.

X. EVALUATION SUBCOMMITTEE REPORT

• Update from September 3, 2010 HIV/AIDS Data Summit
David Giugni distributed a copy of the summary for the September 3rd HIV/AIDS data
Summit held at the California Endowment to the PPC members. Mr. Giugni highlighted a
few items from the summary including 141 participants (including presenters and
facilitators) attended and seventy-nine evaluation forms were received and data analyzed.
Overall, the summit was a success with a great turnout.

Mr. Giugni acknowledged the work of Miguel Martinez and the Evaluation Subcommittee. Additionally, Terry Smith commended Miguel Martinez and the work of the Evaluation Subcommittee.

• Revised PPC Membership Demographic Table
Juli-Ann Carlos referenced the PPC Membership Demographics Table document included
in the meeting packet. Ms. Carlos shared the PPC membership demographics table
document has been updated to reflect the priority and critical populations referenced in the
Prevention Plan. Ms. Carlos shared the report reflects the percentages of persons living
with HIV/AIDS by gender, race/ethnicity, age, and priority and critical populations.
Additionally, Ms. Carlos explained the footnotes on the bottom of the page and reported the
numbers are estimates. Under the Priority and critical Populations, the estimate of the
percentages is the sexual transmission mode. No data is available to estimate the
percentage for Sex Workers. There was a question regarding breaking down the percentage
of Transgender by female to male and male to female. However the number of cases is too
small and most of the cases reported in Los Angeles are male to female. Ms. Carlos noted
the Non-gay identified MSM definition used from the Prevention Plan, "men who have sex
with multiple genders" was used to obtain the estimates for this category and in this
estimate, it does not include men who have sex with transgender women.

XI. ANNOUNCEMENTS

Kathy Watt announced the Los Angeles jurisdiction applied for and is being funded by the Centers for Disease Control and Prevention (CDC) for the 12 MSA FOA (12 most highly impacted jurisdictions in the metropolitan services area funding opportunity announcement).

Terry Smith announced a draft of the letter regarding the reduction of test kits has been developed and will be going out shortly.

Elizabeth Mendia announced the Whittier Rio Hondo AIDS Project has received notification from the Los Angeles Chapter of Women in Films that they (WRHAP) have been awarded an

opportunity to work with Women in Films to develop a Public Service Announcement to promote testing for Latina and African American women.

Juli-Ann Carlos announced approximately two months ago, she informed the PPC of an error in the EPI Profile, the correction has been made and the Errata sheet is on the back table.

Ricki Rosales announced:

- 1. The City of Los Angeles AIDS Coordinator's Office recently funded UCLA to study on an application called "Grinder", a mobile hook-up application, to look at behaviors and risk when individuals utilized those types of applications.
- 2. The City of Los Angeles AIDS Coordinator's Office three-year Prevention contracts will come to a close in March and anticipate releasing a new RFP in the next couple of weeks.

Trevor Daniels announced he is attempting to identify some resources to actively recruit mental health professionals in HIV/AIDS field. Mr. Daniels announced he is one of the 164 HOPE mental health providers in the United States charged with teaching fellow psychologists to work with people who have HIV and/or AIDS.

Phil Hendricks announced the annual fundraising event "AIDS Walk Los Angeles" is scheduled on Sunday, October 17th in West Hollywood. Mr. Hendricks invited and encouraged everyone to participate in this event.
