# I. ROLL CALL

Roll call was taken at 12:10 PM and a quorum was present.

# II. COLLOQUIA PRESENTATION

"Testing & Linkage to Care Plus (TLC+) Implementation Concerns"

Ms. Uyen Kao of the Center for HIV Identification, Prevention and Treatment Services
(CHIPTS) provided some background and introduced Richard Jefferys of the Treatment Action
Group who provided a power point presentation.

Mr. Jefferys' power point presentation indicated Testing & Linkage to Care Plus (TLC+) is a new model intended to increase HIV testing and linkage to care for people who test HIV+. The goal is to not only improve individual health outcomes but also lower risk of onward transmission by ensuring timely prescription of antiretroviral therapy (in accordance with current guidelines) and maintenance of viral load suppression. It is thus ultimately hoped there will be a public health impact in the form of lower HIV incidence in the community. The United States HIV Prevention Trials Network (HTPN) is now initiating a pilot study of the concept in Washington, DC and the Bronx, NY, known as HPTN065 (http://www.hptn.org/research\_studies/hptn065.asp).

Although the central tenets of TLC+ are relatively uncontroversial-increasing HIV testing rates and linkage to ongoing primary care-the idea of treatment to prevent risk of onward HIV

transmission has generated some heated debates about the tension between individual rights and public health goals. The discussion reviewed some of the concerns that have been raised about the implementation of TLC+, in the context of the evidence that is driving support for the approach.

There was a question and answer period following the presentation.

# VII. COMMUNITY CO-CHAIRS REPORT

- PPC/COH Integration Collaboration Task Force Report/Update
  Terry Smith provided an update on the PPC/COH Integration/Collaboration Task Force.
  The membership has changed. The COH representatives/members are: Michael Johnson,
  Robert Butler, Lee Kochems and Jennie O'Malley. The PPC representatives/members are:
  Terry Smith, AJ King, Josh Riley and Ricki Rosales. Kathy Watt will represent both the
  PPC and COH. Craig Vincent-Jones and Sophia Rumanes will continue in their roles as
  staff representatives. A meeting has not been scheduled. However, both bodies are
  committed to the Integration/Collaboration Task Force. The projects the PPC has agreed to
  tackle are the following: Continuum of Care (linking prevention through the continuum)
  and TLC+.

# VIII. TLC+ PRESENTATION

Dr. Jennifer Sayles, Medical Director of Office of AIDS Programs and Policy (OAPP), provided a power point presentation titled "Testing Linkage to Care Plus Treatment (TLC+): Los Angeles County". The power point presentation included:

- 1. The definition of TLC+
- 2. The elements of TLC+
- 3. The goal of TLC+
- 4. Los Angeles County background information (including HIV/AIDS statistics, the typical course of the HIV infection, the effects of counseling in conjunction with HIV testing, cost effectiveness, HIV positivity rates, etc.)
- 5. Additional topics discussed were: Sexual transmission of HIV according to viral load, antiretroviral therapy, HIV Positivity rates, statistics on Linkage to Care for Los Angeles County, Linkage to Care Activities for Los Angeles County, highlighted the changes in the Guidelines for the use of Antiretroviral Agents in HIV infected adults, Community Viral Load and charts reflecting Viral Load (VL) by Zip Code.

Challenges to the implementation of TLC+ in Los Angeles County are the following:

- 1. The geography of Los Angeles County
- 2. The fragmented health care system
- 3. Resources to scale up the components
- 4. HIV stigma and homophobia

- Identify emergent prevention issues and engage community and expert support.
- Support broad based community participation.
- Coordinate and oversee ad hoc meetings.
- Role of prevention in TLC+
