I. ROLL CALL

Roll call was taken at 12:15 PM and a quorum was present.

II. COLLOQUIA PRESENTATION

"Opportunities for Expanding HIV Testing Through Health Reform"

Dr. Rosemary Veniegas of the Center for HIV Identification, Prevention and Treatment Services (CHIPTS) provided some background and introduced Carl Schmid, Deputy Executive Director of The AIDS Institute in Washington, D.C. who provided a power point presentation titled "Opportunities for Expanding HIV Testing Through Health Reform".

Mr. Schmid's power point reviewed the Patient Protection and Affordable Care Act and how HIV testing could be covered under various programs and payers including Medicaid, Medicare and private insurers. Additionally, it was explained how each payer could cover routine HIV testing or HIV testing only for high risk individuals or in high risk settings. Suggested steps to ensure maximum coverage of HIV testing as the law is being implemented were outlined. HIV testing is just one preventative service that could be covered under the law. Additionally, Mr. Schmid identified other services that could possibility be covered under the law.

There was a question and answer period following the presentation. A copy of the power point presentation titled "Opportunities for Expanding HIV Testing Through Health Reform" is on file.

John Riley announced that at the May PPC meeting, Mike Janson, from OAPP, will be presenting some exciting geo-mapping. On behalf of the PPC, Josh Riley welcomed Michelle Enfield to her first meeting.

V. PUBLIC COMMENT

• Jeff Bailey, APLA, announced the HIVLA directory is an on-line directory which can be uploaded from the website and printed. Every week the directory is updated and has approximately 19,000 users. In about thirty days, 1,000 copies of the HIVLA directory will be available for distribution.

In collaboration with Substance Abuse Prevention Control (SAPC), an interactive tool kit for individuals infected with HIV who smoke has been developed (English and Spanish).

- Susan Forrest, HIV Drug and Alcohol Task Force, announced copies of the 2011 Los Angeles County HIV Drug and Alcohol Task Force Training Calendar are on the back table. As of Monday, February 28th, there have been 100,000 hits to the HIV Drug and Alcohol Task Force website.

- Romina Tejada, Bienestar, announced in recognition of National Women and Girls HIV/AIDS Awareness Day, Bienestar is hosting a women's seminar on Saturday, March 12th and Sunday, March 13th from 9:30 AM to 4:30 PM at the Bienestar center in East Los Angeles. VI. PPC COMMUNITY CO-CHAIRS REPORT

Josh Riley announced the April PPC meeting will focus on systems thinking with an interesting exercise which will occur in a two-day period (April 7th and April 8th) by Doc Kline. The intent of the two-day exercise is to assist the PPC in conceptualizing all of the different components of prevention work. On April 7th, the regularly scheduled PPC business meeting will occur at St. Anne's and on April 8th the work will continue at OAPP. It is hoped this exercise will assist in establishing the framework to develop the Prevention Plan. Announcements regarding the April PPC meeting will be emailed.

Terry Smith reminded the group that about a year ago, Craig Vincent-Jones (COH), presented the continuum of care model to the PPC and the prevention piece was not as strong as it should be. Once the continuum of prevention has been completed, it will be merged with the continuum of care. For background information the book *Primer to Systems Thinking* by Donella Meadows is recommended and can be purchased online or at a book store.

Terry Smith announced Los Angeles will be hosting the Urban Coalition of HIV/AIDS Prevention Services (UCHAPS) meeting on March 20th and March 21st. UCHAPS is an opportunity to see the prevention work occurring across the county (in the most heavily impacted jurisdictions directly funded by the Centers for Disease Control and Prevention).

Sophia Rumanes announced the dates and times community join the meeting will be emailed.

VII. GOVERNMENTAL CO-CHAIRS REPORT

Elizabeth Escobedo reported the PPC review of the Centers for Disease Control and Prevention (CDC) Annual Progress (APR) is scheduled on Monday, March 7th from 9:30 AM to 12:00 PM in conference room 907A at OAPP.

Sophia Rumanes stated that on February 24, 2011 Jonathan Fielding, Director of Public Health, announced the Sexually Transmitted Disease Program (STD), HIV Epidemiology Program and the Office of AIDS Programs and Policy (OAPP) will be merged. The merger is in line with the vision for collaboration. As more information becomes available, it will be shared.

Michael Green shared Dr. Fielding's decision to merge was based on the importance of integrating a full range of activities to improve the control of all sexually transmitted diseases

(including HIV) and to maximize departmental units. The process will be lengthy. Any and all questions regarding the merger are to be directed to OAPP.
