HIV/AIDS in Los Angeles County (as of 12/31/2009)

Estimated number of PLWH/A: 62,000 – 65,000

- PLWA : 24,845

Estimated number of PLWH: 25,000

Estimated number of undiagnosed: 13,000

- PLWHA accessing OAPP-funded Services: 18,545
 - 39% of all PLWHA in L.A. County
 - 14,875 (80.2%) had at least 1 medical visit
 - 1,779 (11.9%) were new clients
 - 67% accessed medical care
 - 1,124 (7.6%) returned to the system of care





Distribution of OAPP-funded Services and AIDS Cases








Gender Distribution of All Ryan White Clients, FY 2009 (N=18,545)






Race/Ethnicity of All Ryan White Clients FY 2009 (N=18,545)








Age Group Distribution of All Ryan White Clients, FY 2009 (N=18,545)








HIV/AIDS Status of All Ryan White Clients, FY 2009 (N=18,545)







Primary Medical Insurance Status of All Ryan White Clients, FY 2009 (N=18,545)








Distribution of All Ryan White Clients by Federal Poverty Level, FY 2009

Percent Clients




Federal Poverty Level (FPL)






