## California Assembly Bill 144



## Assembly Bill 144 has been signed into Law.

- California Governor Newsom signed Assembly Bill (AB) 144 on September 17, 2025, which shifts from the State's reliance on CDC's Advisory Committee for Immunization Practices (ACIP) to the California Department of Public Health (CDPH) for setting vaccine recommendations.
- CDPH vaccine recommendations are informed by recommendations by professional medical and scientifically based organizations.
- This law allows a broader scope of practice for vaccine administrations, enabling pharmacists, podiatrists, dentists and optometrists to prescribe and administer vaccines recommended by CDPH.

## How does this affect vaccinations in CA?

- CDPH vaccine recommendations must be <u>covered by CA</u>
   <u>Health Plans</u>, including <u>Medi-Cal managed care plans</u>. This means that if CDPH recommends a vaccine, it will be covered by insurance plans even if it is not recommended by ACIP.
- Provides liability protection to providers who administer vaccines based on CDPH recommendations.
- A pharmacist may independently initiate and administer immunizations recommended by CDPH.



## CDPH Vaccine Recommendations for 2025-2026 Respiratory Virus Season

## All Californians who choose protection are recommended to receive updated COVID-19 vaccines.

CDPH vaccine recommendations were released in collaboration with the <u>West Coast Health</u>
<u>Alliance</u> (WCHA) partners Oregon, Washington and Hawaii and informed by national medical organizations including: <u>American Academy of Pediatrics</u> (AAP), <u>American College of</u>
<u>Obstetricians and Gynecologists</u> (ACOG), and <u>American Academy of Family Physicians</u>
(AAFP).

## Summary of ACIP Meeting September 18-19, 2025

In June 2025, HHS Secretary Robert F. Kennedy Jr. dismissed all 17 standing members of the ACIP citing concerns about potential conflicts of interest, although some reports had previously found no evidence of such issues. New members were appointed, including individuals who have publicly questioned aspects of vaccine policy. The changes at ACIP coincided with broader leadership shifts at the Centers for Disease Control and Prevention (CDC), including the dismissal of CDC Director and the resignation of several senior CDC officials, some of whom expressed concerns about the agency's direction and the role of politics in public health decisions. Despite calls to delay, the reconstituted ACIP convened on September 18–19 to review vaccine recommendations for MMRV, Hepatitis B, and COVID-19. A summary of ACIP recommendations and votes is below.

Importantly, these recommendations do not become federal policy guidance until the acting CDC Director signs a decision memo. This has not occurred to date.

#### **MMRV**

• ACIP recommends separating MMR and Varicella vaccine for all children under 4 years of age. The combined MMRV vaccine is no longer recommended for children under age 4 years but can be used for those 4-12 years of age.

## Hepatitis B Vaccine

- ACIP recommends that providers test all pregnant women for hepatitis B.
- The planned vote to change the pediatric vaccine schedule, including removing recommendation for hepatitis B birth dose given at 0 months, was tabled for future discussion.

### **COVID-19 Vaccine**

- Updates to <u>COVID-19 Epidemiology</u> and <u>Vaccine Effectiveness</u>, Estimated <u>Vaccine</u>
   <u>Coverage</u>, <u>Safety Uncertainties</u> of mRNA COVID Vaccines, <u>Genomics of Vaccine-Induced</u>

   <u>Myocarditis</u>, and COVID-19 <u>Discussion Framing</u> were discussed.
- Recommendation framework: ACIP voted to endorse a model of individual decision
  making based on shared clinical decision-making between a patient and their healthcare
  provider. People aged 65 and older should receive vaccination based on <u>individual-based</u>
  decision making, and people aged 6 months to 64 years should receive vaccination based on
  individual-based decision making with emphasis on risks/benefits discussion.
- Vote on prescription requirement: ACIP voted against a requirement for a physician's prescription for the administration of COVID-19 vaccines.
- Votes on vaccine risks and benefits communication: ACIP voted for CDC to update language about potential risk and benefits. Additionally, they voted for healthcare providers to communicate risk and benefits at the individual-level.

## What does this mean for you:

If ACIP recommendations are approved by the Acting CDC Director:

- MMRV will be removed from the vaccine schedule for children under the age of 4.
- COVID-19 vaccines will remain covered across private health plans, Medicaid, CHIP, and Medicare—there will be no cost-sharing for all individuals aged 6 months and older.
- COVID-19 vaccines will remain available for eligible patients through the Vaccines for Children program.
- Healthcare providers can continue to provide COVID-19 vaccine without a need for prescription.

## **Vaccine Program Management**

PowerPoint Presentation: Recording Returns and Waste

#### **COVID-19 Vaccines**

- Any doses of unused 2024-2025 COVID-19 vaccines for those 6 months through 11 yrs can be returned through the online return form in myCAvax. Please select "Spoiled" for the return reason.
- Providers must report all waste in myCAvax upon expiration of doses (<u>Recording waste job aid</u> log in required. Alternatively, job aid is linked above).

### CA Bridge Access Program (BAP) Closeout

- Participating providers must report BAP waste in myCAvax upon expiration of doses (<u>Recording waste</u>
  job aid).
- Navigate to the myCAvax dashboard from the home page and pull BAP reports. Once program closeout is completed, you will not be able to access this historical data.
- BAP funding will no longer be available for the upcoming Federal Fiscal Year. COVID-19 vaccine will be available to LHD-317 Providers for use on uninsured/underinsured adults for the 2025-2026 season.

## State General Fund (SGF) Flu

- SGF flu ordering is now open.
- Review the program participation email from <u>vaccinereq@ph.lacounty.gov</u> sent to Primary and Backup Vaccine Coordinators on Tuesday, August 19, 2025.
- To be approved for ordering, providers who are not active in the VFC, VFA, or LHD 317 Programs will need to submit additional documentation for their storage units. Providers who meet this criterion have been contacted by <a href="mailto:vaccinereq@ph.lacounty.gov">vaccinereq@ph.lacounty.gov</a> with more information.

- An important reminder to report all immunizations administered into the California Immunization Registry (CAIR) as required by state law AB 1797. The quality and integrity of CAIR data depend on your reporting of every immunization without exception. ## **Education Sector Updates and Reminders**

## **Annual Immunization Assessment Reporting Portal is Open for Schools and Childcare Facilities**

Mandatory immunization assessment reports for schools and childcare facilities must be submitted via <u>CAIR-Hub</u> (formerly known as Shots for School) by December 5, 2025. Annual assessment and reporting is required by law (<u>California Health and Safety Code, Sections</u> 120325-120375) in California for children in pre-k, kindergarten, and seventh grade.

### Medical Exemptions for Required Immunizations

If a provider determines that a child needs a medical exemption from an immunization required for school entry, parents/guardians may create an account in <u>CAIR-ME</u> and apply for an exemption. They will receive an exemption application number to give to their child's physician. The physician (who must be licensed in California) may register for an account in CAIR-ME and log in to issue the medical exemption. Once the medical exemption is issued, the physician prints the form and provides a copy to the family to give to their child's school or childcare facility. ## Homeopathic Vaccines do NOT meet CA School Entry Law Requirements

Nosodes, homeoprophylaxis vaccines, or homeopathic vaccines do NOT meet the immunization requirements for attendance in California schools and childcare facilities. For more guidance on this topic, please see <u>California Code of Regulations</u>, <u>Title 17</u>, <u>section 6000 (m)</u>.

## Transcribing Records in CAIR

Unfortunately, we have recently learned that several records falsified by parents/guardians and/or including doses for "homeopathic" vaccines have been entered into CAIR. Before transcribing vaccine records into CAIR, it is recommended that clinic staff contact the administering provider office to confirm the doses, particularly if the original record provided by parents/guardians is limited in detail (e.g., no lot numbers, minimal provider information, etc.).

## **Strategies to Promote Vaccines**



## Speak with your patients.

Offer and recommend vaccines as part of routine care. If patients or parents have questions, listen and provide reassurance. Leave the door open to revisit the conversation later, should they decide not to get vaccinated during that visit.
