

Number of COVID-19 Cases by Episode Date, Hospitalizations and Deaths by Date of Death


March 1, 2020 – September 8, 2021





Delta Variant Cases and Percentage of Specimens Sequenced by Week of Specimen Collection




Lambda and Mu Variants, Cases by Week of Specimen Collection



Covid Among Fully Vaccinated People in LAC as of September 14th, 2021


- 5,442,728 fully vaccinated













Recent Local and Federal Vaccine Mandates

Students

- **Culver City Unified School District, 8/18/21:** All students 12+ required to be fully vaccinated by 11/19/21
- **Los Angeles Unified School District, 9/9/21:** All students 12+ required to be fully vaccinated by 12/19/21

Healthcare Workers

- **LA County HOO, 8/12/21:** All health care workers and home health care workers required to be fully vaccinated by 9/30/21

Government employees

- **Los Angeles County, 8/5/21:** All county employees required to be vaccinated by 10/1/21 by Board Chair Executive Order
- **Los Angeles City, 8/20/21:** All city employees required to be vaccinated by 10/5/21
- **Federal, 9/9/21:** Vaccination required among all federal workers and contractors; all HCWs in Medicare/Medicaid-funded settings

Workers at businesses with >100 employees

- **Federal, 9/9/21:** All employers with 100+ employees required to verify vaccination or weekly negative test for all employees

Customers/attendees at certain establishments/events

- **Los Angeles City, 8/11/21:** Finalizing an ordinance requiring proof of vaccination from all people entering many indoor public space
- **City of West Hollywood, pending ratification 9/20/21:** All adults entering high-risk food/drink/fitness establishments required to be vaccinated
- **Federal, 9/9/21:** Large entertainment venues asked to verify vaccination or recent negative test for entry
- **LA County HOO, 9/17/21:** Mega events/event venues required to verify vaccination or recent negative test for entry by 10/7/2021; bars, lounges, nightclubs, breweries, wineries, and distilleries required to verify vaccination (at least 1 dose) by 10/7/2021 and full vaccination by 11/4/2021



HOO Targeted Vaccination Mandate for High-Risk Settings

- Require **vaccine verification** or a negative test <72 hours prior at outdoor mega events for all participants; this includes venues/events with more than 10,000 attendees that are ticketed with controlled points of entry to a well-defined area (e.g. sport and music arenas, theme/amusement parks)
- Require **vaccine verification** for customers and employees at indoor portions of bars, wineries, breweries, nightclubs, and lounges (establishments with either no restaurant permit or a low-risk restaurant permit); children under 12 are exempt
- Strongly recommend **vaccine verification** at indoor portions of restaurants
- Maintain **indoor masking requirement**



Our Plan for Administering Booster Shots, If/When Approved

- Existing network of over 1,300 fixed sites (hospitals, clinics, pharmacies, community sites, medical provider offices) with current collective capacity of 130,000 doses/day and ability within a few weeks to expand to 200,000 doses/day
- Focused support for SNFs using the LTC pharmacy partnerships established earlier in the pandemic and DPH mobile strike teams
- Mobile teams remain focused on those still needing initial vaccination dose and vulnerable populations (homebound, shelters, LTC facilities)
- Tracking FDA recommendations and CDC actions to finalize plans (targeted groups/timing for boosters)
