Homicides & Firearm Deaths in Los Angeles County

Homicide was the leading cause of death for residents aged 5-44 years in Los Angeles County¹, disproportionately impacting youth and young adults, particularly minorities and males in the county's most underserved communities. Additionally nearly one-third of all firearm deaths in the county are suicides, and these rates have been increasing.

Homicides

- There were a total of 9,917 homicides in Los Angeles County between 2000 and 2009; approximately 43% of these were gang-related homicides.²
- Homicide was the leading cause of premature death for Hispanic and African American males.
- Homicide rates among African American males were six times higher than the county overall.
- Homicide was the leading cause of premature death in SPA 6 (South LA).
- Homicide was the second leading cause of premature death countywide (1999-2008) behind coronary heart disease. While an average of 4 years of life was lost from every coronary heart disease death, an average of 46 years of life lost was lost from every firearm homicide.

Firearm Deaths

- In 2010 there were 798 firearm deaths in Los Angeles County, including 504 homicides, 281 suicides, and 13 other intent (unintentional shooting, legal intervention, undetermined).
- Firearm death rates among youth in SPA 6 (South LA) were nearly eight times the county overall.

Homicides

- Firearm homicide rates in Los Angeles County remain higher than the national rate: in 2010 the firearm-related homicide rate was 4.8 per 100,000 (compared to 3.2 per 100,000 nationwide³).
- A firearm was used in 78% of all homicides.⁴ Among youth (age 15-24), 91% of homicides are firearm-related.
- Firearm homicide was the leading cause of death for youth (age 15-24) from 2000-2009. Nationally, the leading cause of death for this age group was motor vehicle traffic.⁵

- More than half (58%) of all deaths among African American youth were caused by firearm homicide.

Suicides

- Nearly one-third of all firearm deaths in Los Angeles County are suicides.
- Firearm-related suicide rates have been increasing in the county while firearm-related homicide rates have decreased.
- Firearm-related suicides are the fourth leading cause of injury death among Males, Whites, and residents of SPA 1, 2, and 5.
