FAP MISSION

Our mission is to provide trauma informed responses, services and support to the families, friends, and witnesses following an in-custody death or fatal use of force at the hands of Los Angeles County Sheriff's Department.



FAMILY ASSISTANCE PROGRAM (FAP)

The FAP consists of trained mental health clinicians who receive and respond to the incident following an in custody death or fatal use of force at the hands of Los Angeles County Sheriff's Department. These incidents may occur in custody or in community, hospital, or jail settings. OVP clinicians serve as a primary point of contact for families, friends, and witnesses impacted by such incidents and offer immediate support; connect them to relevant services; and communicate, to the next-of-kin, investigative and other important updates and information following a death.

- Crisis Counseling and Emotional Support
- Burial Assistance
- Individual and Family Counseling
- Trauma Informed Care
- Advocacy and Liaison Services
- Linkage to Support Groups and Community Resources
- System Navigation
- Referrals to Specialized Services
- Long-Term Follow-Up and Support
