# CalOMS Submission Requirements & Guidelines



- **CalOMS is required for:**
  - **New admission**, including Recovery Services, ASAM 0.5, OTP Detox
  - Any changes in **services/level of care**
  - Any changes in **location**
  - **Annual update** if a participant remains in treatment for one year or longer
- **CalOMS is not required if only:**
  - The movement within the same residential facility/location from 3.1 to 3.3. to 3.5 or reverse order
- **No concurrent CalOMS are allowed for the same type of services;**
  - Concurrent CalOMS are allowed in Sage for **Outpatient Program and Opioid Treatment Program** from January 29, 2024



- **Recovery Incentives**

- For patients who receive concurrent services at your outpatient, intensive outpatient, and opioid treatment programs:

- CalOMS is not required

- For patients who receive standalone recovery incentive services at your facility:

- CalOMS is required

- **Initial Engagement**

- For patients ambivalent about enrolling in treatment and did not participate in a structured intake/assessment and not officially enrolled in treatment

- CalOMS is not required

- For patients participated in a structured intake/assessment and enrolled in outpatient, intensive outpatient and opioid treatment programs

- CalOMS is required

# CalOMS Data Submission Deadlines



- **CalOMS Admission Data:**

- Within seven (7) calendar days of a patient’s admission to treatment

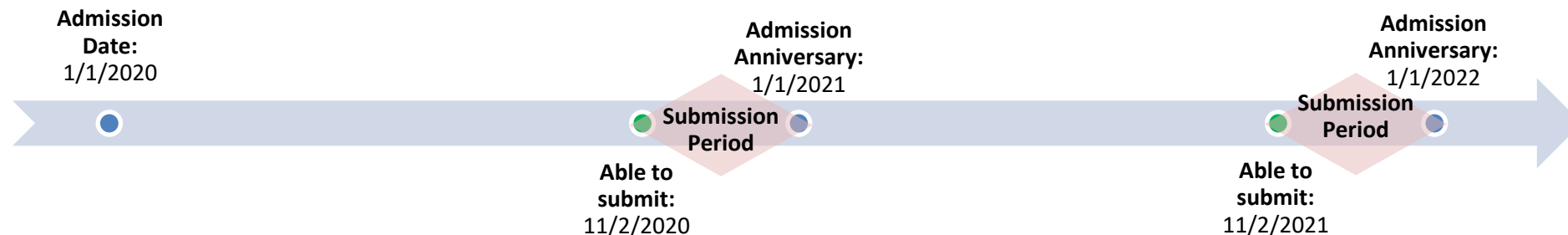
- **CalOMS Discharge Data:**

- On the day of discharge

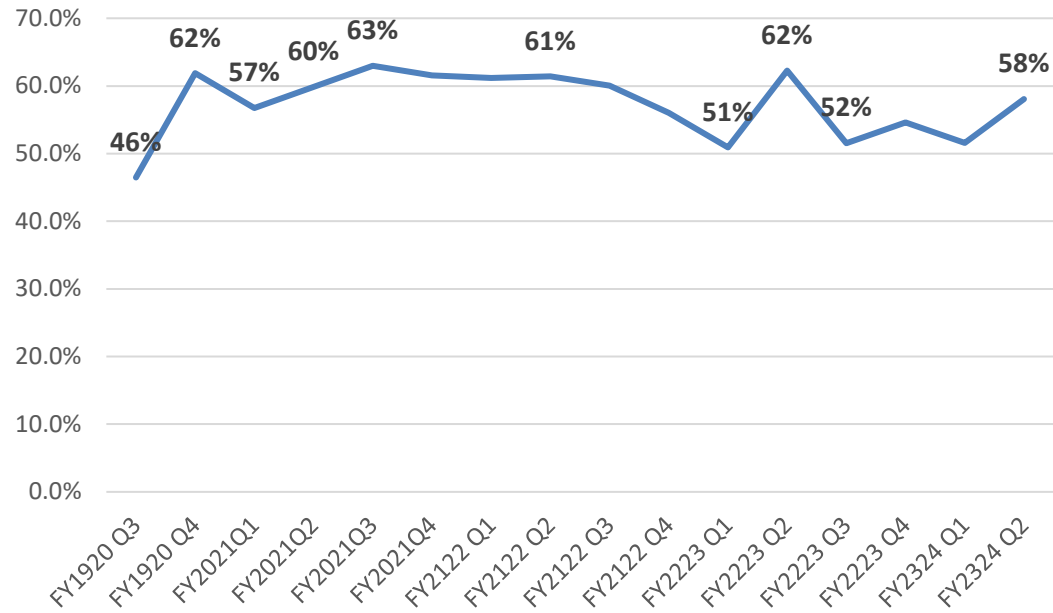
- Discharge Date: the last date of treatment services/dosage
- Discharge Process Date: the date the form is being submitted on

- **CalOMS Annual Updates:**

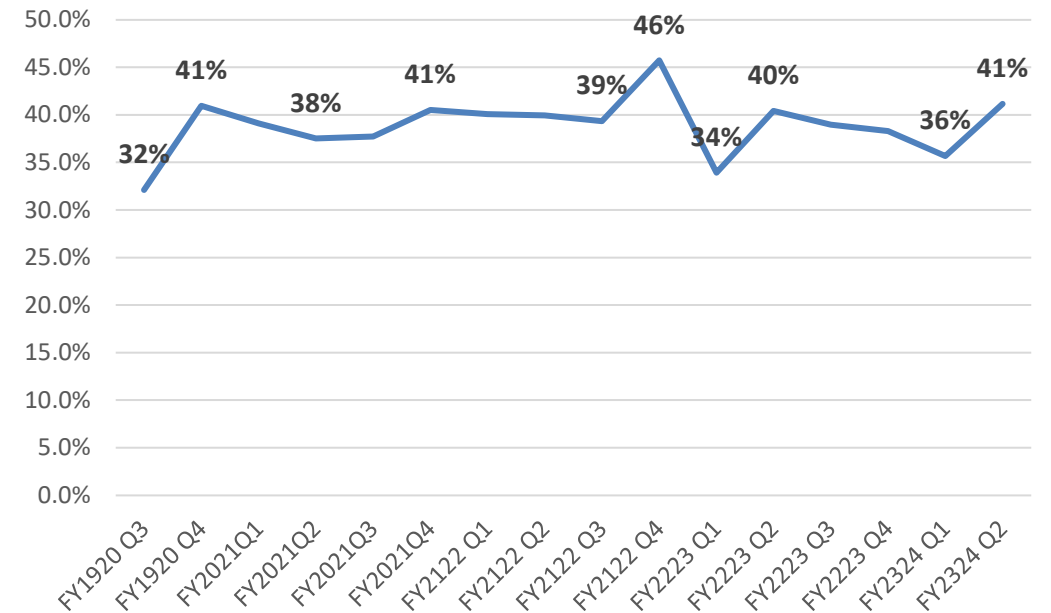
- As early as 60 days before the patient’s admission date anniversary
- NO LATER than the admission date anniversary

## % of Timely Discharge Data Submission

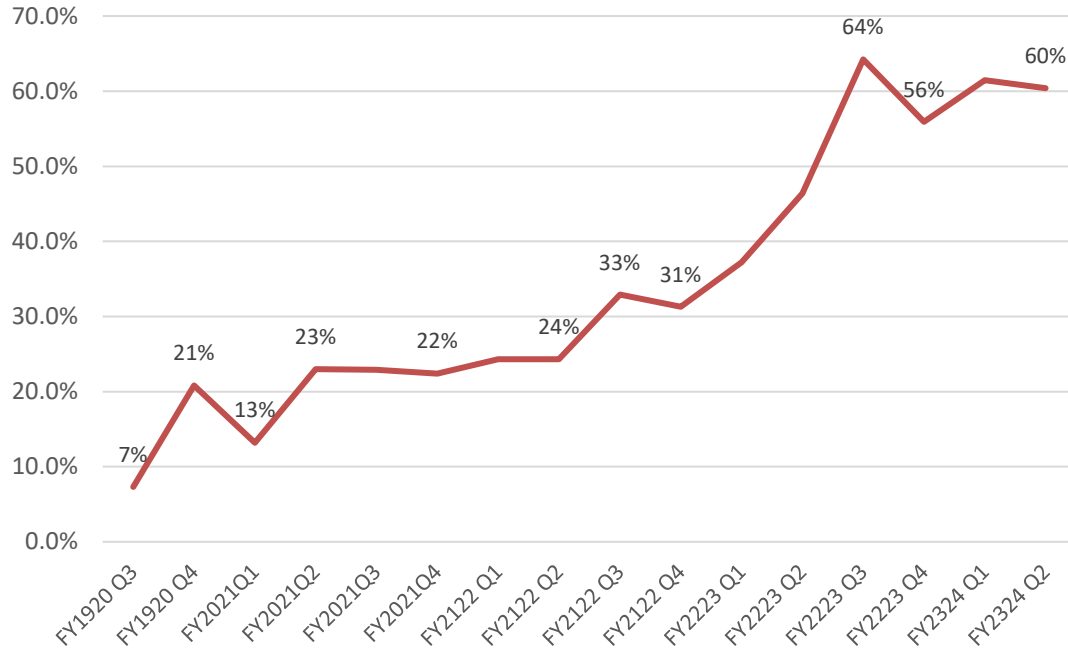


- **Annual Update Data:** After analyzing the state Open Admission Report, we identified **1,146 CalOMS records** from 50 agencies (with records ranging from 1 to 372) as non-compliant for annual updates;
  - These records were sent to each respective agency yesterday.
  - Please submit the necessary annual updates (if the patients are still in treatment) or discharge the mentioned records (if they are no longer in treatment).
  - HODA team will be in contact with agencies to provide technical assistance this week.

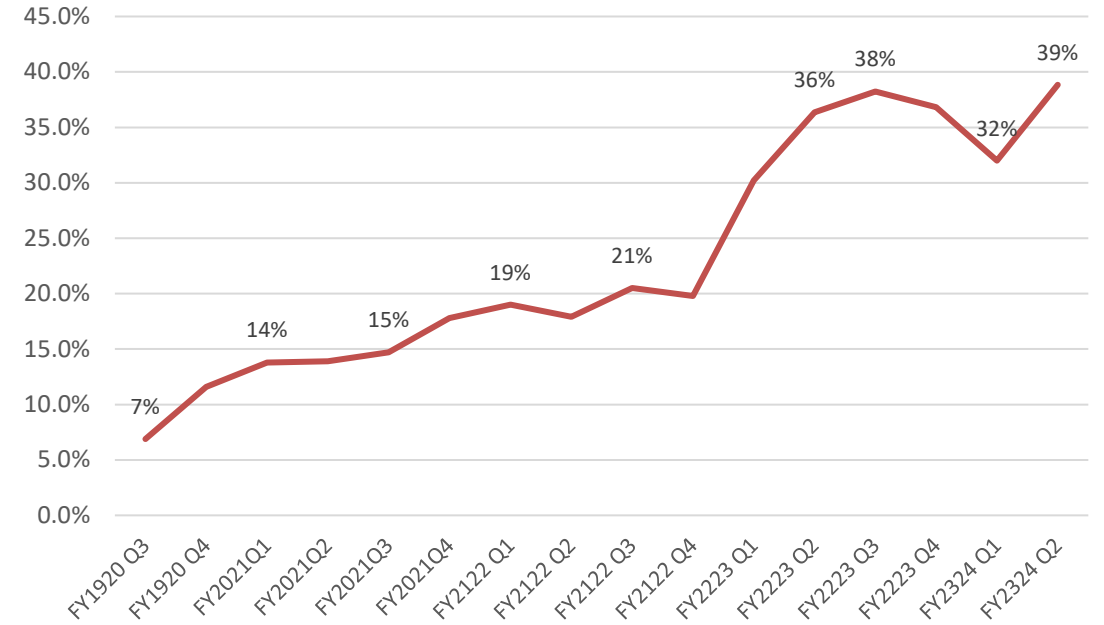
# CalOMS Completeness Overview
