SUPPORTING PEOPLE EXITING INSTITUTIONS THROUGH BRIDGE HOUSING

People exiting institutions (hospitals, prison/jail, foster care, etc.) are faced with difficult hurdles that often lead to or perpetuate homelessness. LAHSA is excited to announce the provision of two new bridge housing programs (HPI & AB-109) for people who have recently left an institution.

WHO IS ELIGIBLE?

- Individuals **18-years or older**;
- Who are **literally homeless AND** have recently **Discharged** from a hospital, prison/jail, or foster care in the **last two months**; OR
- Who are **fleeing/attempting to flee domestic violence or human trafficking AND** have recently **Discharged** from a hospital, prison/jail, or foster care in the **last two months**; OR
- Who are **exiting an institution** where (s)he has resided for **90 days or less** and who resided in an emergency shelter or place not meant for human habitation immediately before entering that institution; AND
- Must be able to perform **Activities of Daily Living** (e.g., eating, bathing, dressing, getting out of bed, toileting).

HOW TO REFER SOMEONE

- Contact the listed providers to verify eligibility and bed availability.

WHAT DOCUMENTATION IS NEEDED? (HPI)

Individuals are required to provide one of the following documents to verify release from institution:

Hospital: (e.g. Hospitals, Behavioral Health, 24-hour Emergency Room stay, or Substance Abuse treatment facilities)

- Release from the hospital ; or
- Other documentation that may prove the individual was checked out of a medical facility.

Jail/Prison:

- Letter from Probation officer;
- An actual jail document outlining release from incarceration ;
- Minute order from the court ;
- Bail document ; or
- Lawyer's letter verifying jail time

Foster Care: (e.g., group homes, foster homes, or other foster care placements)

- ILP Eligibility Verification Form;
- Court documents verifying exit ; or
- A letter from the youth's social worker verifying exit .

* Clients may be able to provide self-certification in an event they are unable to provide proper documentation.

WHAT DOCUMENTATION IS NEEDED? (AB-109)

Individuals exiting prisons and jails are required to bring one of the following verifying forms of documentation:

- Letter from probation officer;
- An actual jail document outlining release from incarceration ;
- Minute order from the court ;
- Bail document ; or
- Lawyer's letter verifying jail time
- * A verification from LA County Sherriff may be required.
